

USPTO FEE INCREASES

June 24, 2008

The USPTO has issued a Proposed Rule Change indicating that it intends to adjust certain patent fees on October 1, 2008 to reflect fluctuations in the Consumer Price Index (CPI). In general, the fees will increase by about 4%. A chart is attached showing the current fees as well as the new fees that will be in place on October 1.

Congress is currently considering legislation that might affect this fee change. However, we do not expect Congress to take action that will change the proposed fees. Thus, we recommend that your planning be based on the enclosed revised fee schedule.

We will continue to monitor the situation closely, and will provide updates accordingly.
