### REVISED USPTO FEE INCREASES

August 19, 2008

Further to our June 24 Special Report, the USPTO has issued a Final Rule Change indicating that it intends to adjust certain patent fees on October 2, 2008 to reflect fluctuations in the Consumer Price Index (CPI). In general, the fees will increase by about 5%, rather than by the 4% predicted in the Proposed Rule Change.

A chart is attached showing the current fees as well as the new fees that will be in place on October 2. This chart should be used in place of the chart attached to our June 24 Special Report in view of the differences between the Proposed Rule and the Final Rule. Please also note that the change goes into effect on October 2 rather than October 1.

Congress is currently considering legislation that might affect this fee change. However, we do not expect Congress to take action that will change the proposed fees. Thus, we recommend that your planning be based on the enclosed revised fee schedule.

We will continue to monitor the situation closely, and will provide updates accordingly.
