## **IMMINENT 15% USPTO FEE INCREASES**

#### December 10, 2010

Further to our March 4, 2010 Special Report, the U.S. House of Representatives has passed an appropriations bill that includes a provision imposing a 15% surcharge on many patent fees through September 30, 2011. The provision is intended as a temporary funding provision to address current USPTO revenue shortfalls. Although the appropriations bill awaits approval by the Senate and signature by President Obama before becoming effective, the Senate is working on a similar appropriations bill that contains a similar patent fee surcharge provision. It is likely that a bill will be sent to President Obama by the end of December, and thus likely that the 15% surcharge will be imposed shortly. The fee increase is scheduled to go into effect 10 days after the legislation is signed by President Obama.

The attached chart shows the current USPTO fees as well as the fees after the 15% surcharge is imposed. Because the new fees will be "rounded" by the Government, they may not precisely match those on the attached chart. However, they will likely be very close to the fees on the chart. Please note that these fee increases have <u>not</u> yet been imposed, but may go into effect by the end of December or by early January. We thus recommend that your planning be based upon the enclosed revised fee schedule.

We will continue to monitor the situation closely, and will provide updates accordingly.
