## **USPTO FEE INCREASES**

#### July 1, 2011

The USPTO has issued a Proposed Rule Change indicating that it intends to adjust certain patent fees on October 1, 2011 to reflect fluctuations in the Consumer Price Index (CPI). In general, the fees will increase by about 2.3%. The actual adjustment will be based on the most recent annual increase in the CPI, as reported by the Secretary of Labor, at the time the final rule is implemented. A chart is attached showing the current fees as well as the new fees that are projected to be in place on October 1.

Both the U.S. Senate and the U.S. House of Representatives have recently passed separate but similar patent reform legislation. It is now in a conformation process that may lead to its enactment this year, possibly as early as this summer. The version of the patent reform legislation passed by the House of Representatives, which appears likely to be enacted in this regard, contains a provision that would impose a 15% surcharge on most patent fees. It is not clear whether the USPTO will also implement the proposed 2.3 % fee adjustment if this 15% increase is implemented. We recommend that our clients also plan for the 15% surcharge on patent fees, which would take effect 10 days after enactment of the legislation. However, we cannot predict with certainty whether or when the patent reform legislation may be enacted.

Thus, we recommend that your planning be based at least on the enclosed revised fee schedule, which includes the anticipated 2.3% increase on October 1. Further, as discussed above, it would also be prudent to plan for the 15% patent reform legislation increase, which may become effective even before October 1.

We will continue to monitor the situation closely, and will provide updates accordingly.
