FURTHER USPTO FEE INCREASES

October 4, 2007

Our August 31, 2007 Special Report explained a Final Rule promulgated by the USPTO that adjusted certain patent fees on September 30, 2007 to reflect fluctuations in the Consumer Price Index (CPI). However, on September 28, 2007, the USPTO issued a corrected Final Rule to correct oversights to adjustments to certain patent fees.

Specifically, the corrected Final Rule corrects the adjusted fees associated with extension fees for responses filed in the fourth or the fifth month. A corrected chart is attached showing the previous fees as well as the new fees that became effective on October 1, 2007.

As we discussed in our August 31 *Special Report*, Congress is currently considering legislation that might affect this fee change. However, we do not expect Congress to take action that will change the fees. Thus, we recommend that your planning be based on the enclosed revised fee schedule.

We will continue to monitor the situation closely and will provide updates accordingly
